

NOTIFICATION OF VACANCIES FOR DIRECT RECRUITMENT OF THE TEACHING/OTHER ACADEMIC POSTS IN VARIOUS ADARSH SANSKRIT MAHAVIDYALAYAS (ASMs)/ADARSH SANSKRIT SHODH SANSTHANS (ASSSs) RECOGNIZED UNDER THE CENTRAL SCHEMES FOR SANSKRIT PROMOTION

The Central Sanskrit University, Delhi (CSU) is the nodal agency of the Ministry of Education, Govt. of India for implementing the Central Schemes of the Govt. of India for Sanskrit Promotion. Under one of the Central Schemes i.e. “**The Scheme for Financial Assistance to Institutions Recognized as Adarsh Sanskrit Mahavidyalayas (ASMs)/Adarsh Sanskrit Shodh Sansthans (ASSSs) (Revised Adarsh Scheme-2022)**”, various institutions have been recognized as ASMs/ASSSs, in different parts of the country, for financial assistance. In this context, under the provisions contained in this Scheme, the Central Sanskrit University, Delhi invites online applications from Indian nationals for direct recruitment to the following **Teaching/Other Academic Posts** in various ASMs/ASSSs recognized under aforesaid Scheme on behalf of these grantee Adarsh institutions. **While advertisement of this has also been issued in employment News (to be published on 29.11.2025) and all India newspapers on 20.11.2025, these publications are only for general information of the interested applicants. In this regard, all interested applicants are strictly advised to go through this notification on CSU website along with its online link for filling application for full and complete information.**

The applicants are required to **apply only online** on the link given at the CSU’s Website www.sanskrit.nic.in under “**Recruitment/Notification**” heads and the link is also available in the websites of the concerned 16 ASMs/ASSSs, located in various states of country. Category (e): Multiple Disabilities from amongst persons under clauses (a) to (d) including Deaf-Blindness
4. # against lien vacancy.
5. Applicants must submit the online application and ensure that the corresponding hard copy reaches the office by the specified deadline. Applications not fulfilling this dual requirement will be rejected without any further correspondence. If required, applicants may expand the online application columns to include any required supplementary information.

The applicants are advised to note the following points: -

1. Schedule of submission of online application, followed by submission of Hard copy, is as under: -
 - Starting date of Online Registration/Submission of application: 20.11.2025 (Thursday).
 - Last date of Online Registration/Submission of application: 20.12.2025 (Saturday) by 11.30 p.m. (IST) [after which the link will be disabled]
 - Last date of receipt of hard copies:- 29.12.2025 (Monday) by 6.00 p.m. (IST).
2. The above advertised posts are specific to respective 16 ASMs/ASSSs and are advertised on their behalf as per the present reservation rules and based on inputs received from the concerned ASMs/ASSSs.
3. It is the sole responsibility of the applicant to ensure that the subject and post for which he/she is applying and as well as the reservation category against which applied, are available under the respective ASM/ASSS as specified in the advertisement. Any application submitted with incorrect or mismatched information shall be become infructuous.
4. Qualifications and other eligibility criteria will be the same as per UGC, Govt. of India norms, Regulations on Recruitment Rules of CSU, Ordinances of CSU, Revised Adarsh Scheme-2022 and as specified in this detailed notification, which is available in the website of the CSU and concerned ASM/ASSS. Further, any amendments shall be strictly in accordance with the guidelines prescribed by the UGC, Govt. of India norms, Regulations on Recruitment Rules of CSU, Ordinance of CSU & Revised Adarsh Scheme-2022, from time to time. These posts will be filled up through Direct Recruitment.
5. **Qualifications and other eligibility criteria for the above-mentioned posts are at Annexure-I.**
6. **The persons appointed against the above advertised post(s) shall be governed as per the provisions of “The Scheme for Financial Assistance to Institutions Recognized as Adarsh Sanskrit Mahavidyalayas (ASMs)/ Adarsh Sanskrit Shodh Sansthans (ASSSs)-2022” and its amendments as issued from time to time.**
7. Recruitment process for above posts in Adarsh Sanskrit Mahavidyalayas (ASMs)/Adarsh Sanskrit Shodh Sansthans (ASSS) shall be conducted centrally at the Central Sanskrit University, Delhi on behalf of these grantee institutions as per UGC, Regulations on Recruitment Rules of CSU, Revised Adarsh Scheme-2022 and established procedures duly approved by the Competent Authority of CSU. Based on the recommendations of Selection Committee, the

CSU shall draw the merit panels, subject-wise and institution-wise, as per requirement of the above posts in the concerned ASM/ASSS. While the online application has the provision for choice of place of postings, the candidates can indicate/modify their place of choice for preference of posting at the time of interviews also. Once the interview of the candidate is over, no further modifications will be allowed.

8. **Appointing authority and status of the employee:** The selected candidate(s) will be appointed by the respective Adarsh Sanskrit Mahavidyalaya (ASM)/Adarsh Sanskrit Shodh Sansthan (ASSS) and the candidate will be their employee in which he/she is appointed by the Management Committee of respective ASM/ASSS, and not of the Government of India or Central Sanskrit University, Delhi. The Central Sanskrit University, Delhi is acting as a Nodal Agency for conducting merely the central recruitment process on behalf of these institutions under the provision of the Revised Adarsh Scheme-2022. All applicants may note that **“All persons employed on teaching as well as other academic posts in the ASM/ASSS receiving financial assistance under this scheme shall be the employees of that particular ASM/ASSS, and not of the Government of India/Central Sanskrit University. They shall not for any purpose be compared with the employees of the Government of India or the Central Sanskrit University under any circumstances. The liability of University shall be limited to the extent of providing grants/financial assistance to the ASMs/ASSSs and administrative control on the issues prescribed in this Scheme.”**
9. The applicant who wishes to apply for Teaching post in numerous institutions, may choose (in the online application) upto any of the 05 (five) of the total 16 (sixteen) institutions on his/her priority basis as per availability of the post applying for in online application. However, there is also an additional option for choosing for the posts of remaining institutions (recognized under the scheme) i.e. any ASM/ASSS in the country. Selection of this option shall signify the candidate’s consent to be considered for appointment in institutions other than the five Adarsh Sanskrit institutions indicated by them. The candidates can indicate/modify their place for preference of posting at the time of interviews also. Once the interview of the candidate is over, no further modifications will be allowed. The Applicants, which selected only up to five institutions and did not choose additional option (Dropdown: Select Institute Priority) will not be considered for the other remaining institutions, regardless of their merit in comparison with other candidates being considered for those institutions.
10. **CSU Cadre Recruitment Rules (CRRs)/Ordinances are primarily meant for selections in CSU. Rule 3 of the CRRs clearly says that they are applicable for CSU employees only. At the same time, Para 40 of the Revised Adarsh Scheme, 2022, prescribes that recruitment process for teaching/other academic/non-teaching posts in ASMs/ASSSs shall be conducted centrally by the CSU, Delhi as per regulations/ordinances of UGC/CSU. Therefore, for the purpose of Recruitment/Selections, the Regulations/Ordinance of CSU, are taken as model CRRs/Ordinances for recruitment/selection in ASMs/ASSSs. It is to be noted that, CRRs of CSU are taken as model CRRs for ASMs/ASSSs, as prescribed in Para 40 of the Revised Adarsh Scheme-2022, and their application is mutatis mutandis as laid down in Revised Adarsh Scheme-2022. The application of these model CRRs, will not accrue any right/additionality to any appointee in ASM/ASSS, which is not consciously and expressly provided in Revised Adarsh Scheme-2022.**
11. Each applicant will have to pay application fee of Rs. 3,000/- (Rs. 1,500/- for SC/ST/PwBD) which can be paid through Online Mode only (provided in the online application). Any other mode of payment shall not be accepted towards application fee. The application fee shall be paid strictly as per the applicant's category and amount prescribed, failing which, the application will be deemed as invalid. Fee once paid will not be refunded under any circumstances. Similarly, the excess payment made, if any, shall not be refunded. In cases where the fee paid is less than the prescribed amount, the deficit must be remitted immediately; failing which, the application will be deemed invalid. It is the absolute responsibility of the applicant to show in the application that he/she has paid full prescribed fee. Applicants need to pay the fee only once per subject, even if applying to multiple institutions for same subject. However, if applying for a different subject, it will be treated as a separate application, and the applicant must pay the applicable fee again. It is the absolute responsibility of the applicant to show in the application that he/she has paid full prescribed fee. Incomplete application/applications submitted without requisite fee shall be rejected.
12. After submission of the online application, the candidate shall forward a duly signed hard copy of the application (separately for each subject), along with self-attested copies of all supporting documents and publications to **“The Registrar, Central Sanskrit University, 56-57, Institutional Area, Janakpuri, New Delhi-110058”** through registered post latest by 29th December, 2025 (Monday) by 6.00 p.m. (IST), failing which it may lead to rejections of the candidature. The Central Sanskrit University shall not be responsible for any delay in the receipt of the hard copy of the application beyond the prescribed last date due to

postal delay or any other reason whatsoever. Applications received after the due date shall not be considered, and the candidature of such applicants shall stand automatically cancelled without any further communication. Candidates are directed to submit a duly signed hard copy of the application form along with self-attested copies of all supporting documents and publications, and to produce the originals at the time of Document Verification/Interview or at any subsequent stage of the recruitment process.

13. The fields provided in the online application form may be expanded to furnish necessary additional information.
14. The applicant will be solely responsible for the authenticity of the information submitted by him/her.
15. The last dates as prescribed above may be extended by the Competent Authority of CSU, at its discretion, depending upon the exigencies of the situation. The Competent Authority can also issue amendments to the notification as per rules, if the circumstances so warrant. Notification to this effect will be placed on the website of the CSU, Delhi. The candidates are strictly advised to visit the CSU's website www.sanskrit.nic.in for all further updates/amendments regularly. For all further updates, the candidate has to rely upon the CSU's website only.
16. **Candidates should keep visiting the website of CSU (only) regularly for all important updates/announcements/information/corrigendum/notices and other details related to selection processes at various stages for filling up of the advertised position.**
17. **The detailed procedure of Scrutiny of the Applications, Shortlisting Criteria & Syllabus for OMR based examination consisting of Multiple-Choice Questions (MCQs), Assessment Criteria (Video presentation, Assessment of Research Aptitude and Writing Skills & PPT presentation) for understanding the Abilities of the Shortlisted Candidates, Document Verification and Face-to-Face Interview for all the Shortlisted Candidates will be announced shortly on the CSU's website at www.sanskrit.nic.in**
18. **Right of amendment and communication:** The CSU reserves the right to alter/insert any corrections/additions in the advertisement in the event of any error etc., for which the candidates are advised to be in the lookout for announcements/notifications in the website of CSU. Information relating to selection process of above posts will be communicated through CSU's websites or email communication to the candidates concerned. Candidates are advised to regularly visit the websites of the CSU and/or concerned ASM's or their registered e-mail (including SPAM folder) provided in the application form. No other mode of communication will be adopted by the CSU.
19. **Employed Candidates:** Candidates already under employment should submit/upload "**No Objection Certificate**" from his/her employer, while submitting the application through Online. No Objection Certificate and Vigilance Clearance Certificate, in original, from the employer concerned should be submitted at the time of Documents Verification/Interview.
20. **Advice to avoid delay:** Candidates are advised to apply well before the prescribed last date of submission of application to avoid facing any hindrance in submission of online applications before the last date, due to probable heavy load on network/server. The CSU/Concerned ASM/ASSS will not entertain any complaint in this regard.
21. **Accuracy of contact details:** Candidates must exercise extreme care when entering their contact information, especially their email ID, registered mobile number, and alternate mobile number. Errors in these fields may prevent essential communications, and the CSU will not be responsible for any resulting failure to communicate.
22. **The CSU reserves the right to withdraw the advertisement either partly or wholly at any time without assigning any reason to this effect.**

23. General Terms & conditions:

- (a) *The Central Sanskrit University, Delhi reserves the right to fill up or not to fill up the post without assigning any reason.*
- (b) *Candidates will have to present themselves for the interview/written exam/skill test at their own expenses.*
- (c) *Candidates should bring all certificates in original at the time of verification of documents/interview.*
- (d) *Applications/candidature of applicants are liable to be cancelled/rejected summarily at any stage of the recruitment process in the event of all or any of the following: -*
- i. *Applications being incomplete.*
 - ii. *Application made in the form other than the form available in the institution's website.*
 - iii. *Any variation in the Signatures and Photographs. (All the photographs & signatures, pasted/uploaded/done on the Application Form and also on other Documents must be the same.)*
 - iv. *Fee not paid as per instructions.*
 - v. *Non-forwarding of Self Attested legible copies of all the relevant Certificates/Documents issued by the Competent Authority and clear self-attested photographs in support of the information given in their Application about their Educational Qualifications, Experiences, Percentage of Marks obtained, Proof of Category etc..*
 - vi. ***Not having the requisite Educational Qualification/Experience/Category Status as on the closing date.***
 - vii. *Incorrect information or misrepresentation or suppression of material facts.*
 - viii. *Non-receipt / Late receipt of the prescribed Application Form (Hard Copy) along with self-attested copies of the relevant documents.*
 - ix. *If the candidate is found using unfair means or adopting any malpractice at any stage of selection process.*
 - x. *Non-production of Original Certificates at the time of Verification of Documents.*
 - xi. *Any other irregularity.*
24. Mere possession of eligibility conditions shall not entitle a candidate to be called for interview, unless he/she has been shortlisted as per the procedure prescribed above and also eligible otherwise. **The date for determining the eligibility of all candidates in every respect shall be considered upto the closing date of the online application as prescribed in the advertisement.** In other words, no candidate shall be called for interview if he/she does not possess the minimum qualification and experience etc. as on the closing date of the application for a particular post.
25. Applicants seeking reservation benefits available for SC/ST/OBC/PwBD categories must submit the necessary documents justifying the claim of respective reservation as per Government of India lists/rules/norms. The caste certificate uploaded should be in the format prescribed by the Union Government and should be digitally verified.
26. Acceptance of documents/certificates/claims etc. submitted by an applicant will be subject to their verification by the Competent Authorities/Sources. If, any claim/certificate/document is found to be false/fake/incorrect/malafide at any stage of verification before or after appointment, the document in question shall be summarily rejected and action may be initiated against the candidate for this misconduct including rejection of his/her candidature, debarment for further examinations, cancellation of his/her appointment, if already appointed. It may also lead to initiation of criminal action.
27. **The candidates are advised to compulsorily go through the Revised Adarsh Scheme-2022 before applying for any of the above advertised posts. 28. **The person appointed against any post shall be governed by the SCHEME FOR FINANCIAL ASSISTANCE TO INSTITUTIONS RECOGNISED AS ADARSH SANSKRIT MAHAVIDYALAYAS/ADARSH SANSKRIT SHODH SANSTHANS-2022 (Revised Adarsh Scheme-2022), the service conditions/method of recruitments as amended from time to time and resolutions of the Management Committee of the institution and rules of the Government of India/Guidelines of the UGC, as adopted by CSU for ASMs/ASSSs as case may be, from time to time.**
29. The relaxation in deserving cases shall be provided as per the Rules/Guidelines prescribed by Government of India/UGC/CSU, from time to time.
30. Relaxation in qualification and experience etc. will be applicable as per the UGC/Govt. of India guidelines from time to time. A certificate to this effect issued from the competent authority should be submitted/uploaded while submitting application form(s) for the post(s). Whatever relaxation of qualification including percentage of marks is permitted under the UGC/Gol/CSU guidelines, such relaxation shall also be considered in appropriate cases subject to recommendations of the Screening Committee.

31. It is to be noted that, RRs of CSU are taken as model RRs for ASMs/ASSSs, as prescribed in Para 40 of the Adarsh Scheme, 2022, and their application is mutatis mutandis as laid down in Adarsh Guidelines, 2022. 

- चयनित उम्मीदवार (उम्मीदवारों) को संबंधित आदर्श संस्कृत महाविद्यालय (ASM)/आदर्श संस्कृत शोध संस्थान (ASSS) द्वारा नियुक्त किया जाएगा, और उम्मीदवार उसी संस्थान का कर्मचारी होगा जिसमें उसे संबंधित ASM/ASSS की प्रबंधन समिति द्वारा नियुक्त किया जाता है, न कि भारत सरकार या केन्द्रीय संस्कृत विश्वविद्यालय, दिल्ली का। केन्द्रीय संस्कृत विश्वविद्यालय, दिल्ली संशोधित आदर्श योजना-2022 के प्रावधान के तहत इन संस्थानों की ओर से केवल **केंद्रीय भर्ती प्रक्रिया संचालित करने वाली नोडल एजेंसी** के रूप में कार्य कर रहा है। सभी आवेदक यह ध्यान दें कि: **"इस योजना के तहत वित्तीय सहायता प्राप्त करने वाले ASM/ASSS में शिक्षण के साथ-साथ अन्य शैक्षणिक पदों पर नियुक्त सभी व्यक्ति उसी विशेष ASM/ASSS के कर्मचारी होंगे, न कि भारत सरकार/केन्द्रीय संस्कृत विश्वविद्यालय के। किसी भी परिस्थिति में उनकी तुलना भारत सरकार या केन्द्रीय संस्कृत विश्वविद्यालय के कर्मचारियों से नहीं की जाएगी। विश्वविद्यालय की देयता (Liability) ASMs/ASSSs को अनुदान/वित्तीय सहायता प्रदान करने और इस योजना में निर्धारित मुद्दों पर प्रशासनिक नियंत्रण तक सीमित रहेगी।"**

8. **भर्ती नियमों का उपयोग:** CSU कैडर भर्ती नियम (CRRs)/अध्यादेश मुख्य रूप से CSU में चयन के लिए हैं। CRRs का नियम 3 स्पष्ट रूप से कहता है कि वे केवल CSU कर्मचारियों पर लागू होते हैं। साथ ही, संशोधित आदर्श योजना, 2022 का पैरा 40 निर्धारित करता है कि ASMs/ASSSs में शिक्षण/अन्य शैक्षिक /गैर-शिक्षण पदों के लिए भर्ती प्रक्रिया UGC/CSU के विनियमों/अध्यादेशों के अनुसार CSU, दिल्ली द्वारा केंद्रीय रूप से संचालित की जाएगी। इसलिए, भर्ती/चयन के उद्देश्य से, CSU के विनियमों/अध्यादेशों को ASMs/ASSSs में भर्ती/चयन के लिए **मॉडल भर्ती नियम (Model RRs)/ अध्यादेशों** के रूप में लिया जाता है। यह ध्यान दिया जाना चाहिए कि CSU के भर्ती नियम, आदर्श योजना, 2022 के पैरा 40 में निर्धारित अनुसार, ASMs/ASSSs के लिए मॉडल भर्ती नियमों के रूप में लिए गए हैं, और उनका अनुप्रयोग आदर्श दिशानिर्देश, 2022 में दिए गए अनुसार **यथोचित परिवर्तन सहित (mutatis mutandis)** होगा। इन मॉडल भर्ती नियमों का अनुप्रयोग ASM/ASSS में नियुक्त किसी भी व्यक्ति को ऐसा कोई अधिकार/अतिरिक्त लाभ नहीं देगा, जो संशोधित आदर्श दिशानिर्देश, 2022 में लिखित रूप से प्रदान नहीं किया गया हो।

13. उपर्युक्त निर्धारित अंतिम तिथियों को CSU के सक्षम प्राधिकारी द्वारा, स्थिति की आवश्यकता के आधार पर, **अपने विवेक पर बढ़ाया** जा सकता है। इस आशय की अधिसूचना CSU, दिल्ली की वेबसाइट और संबंधित ASM/ASSS की वेबसाइट पर प्रकाशित की जाएगी। उम्मीदवारों को सलाह दी जाती है कि वे CSU की वेबसाइट **www.sanskrit.nic.in** और/या संबंधित ASM/ASSS वेबसाइट पर **नियमित रूप से देखते रहें**। अपूर्ण आवेदन/अपेक्षित शुल्क के बिना जमा किए गए आवेदन को **अस्वीकार** कर दिया जाएगा।
14. उम्मीदवारों को सलाह दी जाती है कि वे विज्ञापित पद को भरने के लिए विभिन्न चरणों में चयन प्रक्रियाओं से संबंधित सभी महत्वपूर्ण अपडेट/घोषणाओं/सूचनाओं/शुद्धिपत्रों/नोटिसों और अन्य विवरणों के लिए **CSU की वेबसाइट पर नियमित रूप से देखते रहें**।
