Notification for the Engagement of Homoeopathy Consultant (on contractual basis) to the Homoeopathic Dispensary/Metro Railway/Kolkata functioning under " Staff Benefit fund"(SBF)

Sub :- Central Staff Benefit Fund-Engagement of Homoeopathic consultant at Homoeopathic Dispensary on contractual basis under the head "Indigenous system of medicine-reg.

In light of the aforesaid subject, it is intimated that applications in the prescribed format are invited from suitable candidates for making engagement of Part Time Homoeopathic consultant (4 hrs.x 6 days i.e., Monday to Saturday) at Homoeopathic Dispensary/Metro Railway/Kolkata on contractual basis under the Central Staff Benefit Fund head "Indigenous System of Medicine" with following terms & conditions

1. Homoeopathic consultant will be engaged by Central Staff Benefit Fund Committee/M. Rly/Kol. under the aegis of CSBFC and not by the Railways; hence, engaged Homoeopathic consultant shall not be considered as a Railway Employee. The engagement of Homoeopathic consultant shall be liable to be terminated any time prior to the contract period with the notice period of 14 days.
2. The engaged practitioner shall be paid a consolidated honorarium of Rs.37,500/- P.M.(Rupees Thirty Seven Thousand and Five Hundred only) from Central Staff Benefit Fund.
3. The engaged practitioner shall be required to work in Indigenous System of Medicine clinic at Homoeopathic Dispensary which will be kept open for 4 hrs. a day (11.00hrs. to 15.00hrs.) on all working days.
4. The engaged Practitioner shall be required to work in Clinic at Homoeopathic Dispensary/Metro Bhawan & Noapara which will be kept open for 4 hrs. a day (11.00hrs. to 15.00hrs.) on all working days i.e. from Monday to Saturday. It will be closed on weekly holidays and other gazetted holidays.
5. Since the Homoeopathic Consultant purely engaged on contractual basis will not be treated as Railway Employee for any purpose shall not be eligible for any Indian Railway privileges, such as, Transport Allowance, Dearness Allowance, House Rent allowance, Railway Quarters, Passes/PTO, Leaves and Medical facilities etc.
6. The engaged practitioner, not a Railway Doctor, shall not be allowed to issue any sick and fit certificate in favour of the Railway Employees. Private practice shall be permitted but without hampering the normal duty in the Railways.
7. Services of engaged Practitioner shall be terminated upon reaching the age of 70 yrs. or after the completion of period of engagement, whichever is earlier. Even prior to these, the services can be terminated on 14 days' notice on either side.



8. PCSBFC shall not be bound to assign any reason for such termination and this power may be exercised by the Chairman/SBF Committee and the Practitioner will have no right to challenge the order of SBF Committee (Metro Railway/Kol.) to this effect in court of Law. If, it is a contractual engagement, the engagement comes to an end at the end of the contract, so, the qualified candidate does not have rights to seek appointment in Railways and would not be entitled to be absorbed in regular service.

Application form that is in the prescribed format (enclosed) alongwith attested copies of necessary certificates may be sent by ordinary post to " **Dy.Chief Personnel Officer/Gaz, MetroRailway/Kol., 33/1,J.L. Nehru Rd. Kol. 700071**" so as to reach on or before 5.30 hrs.

The Administration is not responsible for any postal delay and belated applications will not be entertained under any circumstance. The candidates must furnish all the relevant information required. Furnishing of false and/or incomplete information shall lead to rejection of the application.
